### Arrangements for the 2014/15 season

The Member Protection Declaration should continue to be utilised for the 2014/15 season. A copy of the current form is attached and is also available via [www.surflifesaving.com.au/members/resources/administration](http://www.surflifesaving.com.au/members/resources/administration)

All new members, as well as any members renewing their membership after a leave of absence of at least one season, are to sign the SLSNSW Member Protection Declaration.

Members under the age of 18 who work with children must sign the SLSNSW Member Protection Declaration form once only and must have their form co-signed by a parent or guardian.

It is an offence for prohibited persons to sign this declaration or to apply for or attempt to obtain, undertake or remain in child-related employment in any capacity, whether paid, volunteering or self-employed. The maximum penalty for falsely declaring that you are not a person prohibited from child related employment is 12 months imprisonment, 100 penalty units (\$11,000) or both.

SLSNSW requires clubs to keep the signed SLSNSW Member Protection Declaration form in a secure location for as long as that member is a part of the club and then 3 years following the phase in period with the new Working with Children Checks.

The completion of the SLSNSW Member Protection Declaration Form must be recorded in SurfGuard. This involves ticking the Member Protection Form Completed box and entering the date for the current year. For any member that works in industries (such as teaching, disability services, youth services etc) that have been phased in to the new Working With Children Check (WWCC) and supplies the Club with their WWCC number, please list in the notes section of the Member Protection section on SurfGuard.

### Moving towards an implementation of the new Working with Children Check

The *Child Protection (Working With Children) Act 2012*, was passed by the NSW Parliament in June 2012 and the Government thereafter announced that a new Working With Children Check would be phased in over the following five years.

This new check is more comprehensive and provides better protection for children. For more information about the Check and the changes visit <http://www.kids.nsw.gov.au/Working-with-children/New-Working-with-Children-Check>

Sporting organisations must start phasing in the new WWCC from 1 April 2015. As such SLSNSW is currently working with the Office of the Children's Guardian on identifying the roles within SLS that will require Checks, policies and procedures to support the new Check, as well as an implementation plan to support this transition.

Communication regarding new processes will be forwarded in due course. In the meantime please continue to utilise the attached Member Protection Declaration form.
